## THE PLAN:

## Friday, June 1st, 2007

- 8:25am Laura \& Ken Depart Philadelphia, PA for Los Angeles, CA on US Air \#1417 (Locator: LKANWG)
- 10:30am Richard and Andrea depart LA for San Luis Obispo
- 11:24am Marblestones arrive LAX and wait for June or Merrell to pick them up outside Baggage Claim - After Lunch, Ken \& Merrell play golf while Laura \& June go shopping.
- 1pm'ish Andrea \& Richard lunch in Pismo at Splash Café (famous for their seafood \& clam chowder) Splash Café, 197 Pomeroy Ave, Pismo Beach, CA 93449 (805) 773-4653 • splashcafe.com
- $1: 45 \mathrm{pm} \quad$ After lunch, I will excuse myself to the restroom and call Kathy Saeger to let her know we are finished lunch and on our way to check in at Sycamore and to prepare the front desk staff.
- $2: 30 \mathrm{pm}$ We checkin but the person behind the desk can't find my reservation. I will pull out a fake reservation confirmation page that I will create with my actual Confirmation Code on it showing we have a Harmony Building room reserved for two nights including two deep tissue massages and a $\$ 50$ gift card to the restaurant.
